Re: Proposal for Presentation of Petitioners' Rebuttal Witnesses

Dear Hearing Chair Doduc and Hearing Officer Marcus:

This letter responds to your order today requiring the Department of Water Resources (DWR) and the U.S. Bureau of Reclamation (Reclamation) (jointly Petitioners) to describe "how the petitioners propose to organize their witness panels (including) the subject of each panel, which witnesses will compose each panel, and the proposed order of rebuttal witness panels."

On March 23 DWR and Reclamation submitted exhibits for the rebuttal portion of Part 1 to the water right change petition hearing associated with the California WaterFix. Petitioners' exhibits contain testimonies of several witnesses who will appear at the hearing in panels, similar to the case-in-chief, based upon common information within the testimony. DWR and Reclamation propose to present their witnesses together where it can provide for efficiency of the proceeding.

Generally speaking, Petitioners will attempt to structure their witnesses around the groupings of (1) engineering and groundwater, (2) operations, modeling, water quality and water rights, and (3) agricultural practices and economics. Mr. Ron Milligan may present individually if his important operational duties require such an approach.

Petitioners will present information of the engineering and groundwater panel at the commencement of its rebuttal oral presentation. This panel will consist of the experts John Bednarski, Praba Pirabarooban, Sergio Valles, and Gwen Buchholz. This panel

will be prepared to present as early as April 25, or as the Hearing Officers determine appropriate for the start date of Petitioners' rebuttal case.

Because the length of cross examination is unknown and highly variable, Petitioners will structure the remainder of the witnesses in a manner that, to the extent possible, avoids gaps in the hearing schedule. Thus, it will be most efficient if flexibility in the presentation order is preserved.
