Thanks for this information on work of the Instream Flow Council.

The San Joaquin COUNTY report in Fall, 2016, showed increasing CRITICAL WATER OVERDRAFT (since 1983).

Pest control advisors say that it can take 100 years for a drop of water to reach the Aquifer.

Then there are project proposals to move water around, with extra costs, counterproductive to growers and farmers. San Joaquin COUNTY is 2/3 of the Delta River area, and we need Sierra waters. The NATURAL GROUND WATER CYCLE is displayed in USDA/NRSC poster, 2012.

Since there is not the water to grab, we are facing a tax grab, with increasing fees, like with Alphabet soup agencies.

Where is common sense, if people care that 50% of fresh food crops for USA, come mostly from NorCAI and Delta River area?

Some say there is plenty of water, maybe compared to Bakersfield Basin. Please foster regional responsibility, like with Salt energy in Desalination (Stanford). Desalination was invented at UCB around 1970, and it has been developed in Israel, Australia and 100 nations. LA Metro knows that concrete (tunnels, pipes and canals) costs more than Desalination. Please allow our concerns in San Joaquin County to be clarified without adding costs to growers, farmers and others in the community. Please restore rivers with tributaries for Aquifer with Fisherman reports and with restorethedelta.org Sincerely,
