On August 9, 2017, Save the California Delta Alliance (SCDA) requested that the deadlines established by the hearing officers to respond to SCDA's or the Department of Water Resources' (DWR) request regarding scheduling of Part 2 of the California WaterFix hearing be extended by one working day. Hearing Officer Marcus has granted SCDA's request and the revised deadlines in the Hearing Team's August 8, 2017 email to the service list have been extended as follows:

The hearing officers have instructed staff to direct petitioners to respond to SCDA's request by noon on Thursday, August 10, 2017 Friday, August 11, 2017. Any other parties who wish to respond to SCDA's or DWR's request regarding scheduling of Part 2 of the hearing may also do so by that deadline. Parties who have already submitted responses need not repeat their comments. The parties will have until noon on Friday, August 11, 2017 Monday, August 14, 2017, to submit any replies to the responses that are submitted by the August 10, 2017 August 11, 2017 deadline.
