Service List and Interested Parties,

On September 11, 2017, we received a request from Friends of the River and Sierra Club California to extend the deadline to file Supplemental Notices of Intent to Appear (NOI) in Part 2 of the hearing on the water right change petition for the WaterFix Project from September 22, 2017, to October 20, 2017. Friends of the River et al. state that they need more time to identify witnesses and confirm their availability for Part 2 of the hearing.

Hearing officer Doduc has considered the request and determined that the deadline should be extended, but supplemental NOI's should be due in advance of the pre-hearing conference scheduled for October 19, 2017. The revised deadline for all designated parties calling witnesses for direct testimony in Part 2 to submit a Supplemental NOI ([Attachment B of August 31, 2017 ruling letter](#)) is **12:00 p.m. October 13, 2017**. The request filed by the Natural Resources Defense Council, Defenders of Wildlife, and The Bay Institute, seeking reconsideration of the hearing officers' August 31, 2017 ruling establishing the deadline to file written testimony and exhibits for Part 2 remains under consideration. The hearing officers will address that request, together with other outstanding procedural matters, in a forthcoming ruling.
