CALIFORNIA WATERFIX HEARING – NOTICE OF ADDITIONAL HEARING DATES FOR PART 2 OF THE HEARING

In “Part 2 Attachment A” to our August 31, 2017 ruling letter, we set a schedule of hearing dates and hearing room locations for Part 2 of the hearing on the water right change petition for the California WaterFix Project. Based on the level of participation in Part 2 of the hearing indicated by the Supplemental Notices of Intent to Appear received by the September 22, 2017 deadline, we have decided to add more hearing days. **This letter notifies hearing participants that we have added hearing dates between January and June, 2018.** The additional dates and locations are shown in bold red font in the attached “Revised Part 2 Attachment A,” which supersedes “Part 2 Attachment A” to the August 31, 2017 ruling letter.
