NOTICE - LIFTING OF TERM 91 CURTAILMENT
TERM 91 WATER RIGHT «WR_STATUS» «pl_no» (APPLICATION NO. «wr_id»)

Your «wr_status» «pl_no» («wr_id») contains a term (Standard Term 91) that prohibits diversion of water under specified conditions. These conditions occur when Supplemental Project Water from the Central Valley Project or the State Water Project is released to meet water quality standards and other in-basin entitlements in the Sacramento-San Joaquin Delta Watershed.

The State Water Resources Control Board (State Water Board) has determined water is now **AVAILABLE** to divert by holders of permits and licenses with Standard Term 91. This notification begins immediately and will remain in effect until further notice. During this diversion opportunity, you must comply with all terms and conditions of your specific water right, especially season of diversion and bypass conditions. You should maintain a record of your diversions since such diversions are still subject to prior rights and reporting requirements. Any diversion in violation of terms and conditions of these notices is subject to enforcement.

PLEASE NOTE: Your water right may be curtailed under Term 91 again, if dry conditions return.
