MITIGATION MONITORING PLAN Water Right Application 31050 Jackson Family Investments III, LLC

This Mitigation Monitoring and Reporting Plan (MMRP) has been prepared in conformance with the California Environmental Quality Act (Public Resources Code § 21081.6). The MMRP has been developed based on the information and mitigation measures contained in the Initial Study/Mitigated Negative Declaration (IS/MND) for Water Right Application 31050. The MMRP lists mitigation measures recommended in the IS/MND for the proposed project and specifies implementation and monitoring responsibilities. Pursuant to Public Resources Code

section 21081.6(b), each of the mitigation measures identified in the MMRP has been included as enforceable permit terms in any permit authorizing construction, diversion, or use of water pursuant to Water Right Application 31050.

Generally, the State Water Resources Control Board, Division of Water Rights (Division) staff will monitor mitigation measures requiring pre-construction actions or submittals. Construction and post construction mitigation measures will be monitored by Division staff as specified in the attached matrix. Implementation of mitigation measures is the sole responsibility of the permittee. Compliance with mitigation measures will be assessed through the Division's routine compliance monitoring activities. Long-term compliance will be assessed when the permit is subject to Licensing, at which time the permittee will be required to demonstrate compliance with permit terms. Non-compliance with mitigation measures may be addressed through the Division's ongoing enforcement program on an as needed basis.

PROJECT DESCRIPTION:

Water Right Application 31050 requests diversion of 156 acre-feet per annum of water from Maacama Creek thence the Russian River, to offstream storage. The purposes of use include irrigation and frost protection of 132 acres of vineyard. Both the reservoir and point of diversion are licensed (Licenses 5674 and 5368, respectively) and currently existing. Application 31050 seeks to add the point of diversion on Maacama Creek (authorized under License 5674) as a supplemental source of water to fill the reservoir (authorized under License 5368). The total amount of water diverted under License 5368 and Application 31050 will be limited to 156 acre-feet per annum. The total amount of water diverted under Licenses 5674, 5368, and Application 31050 will be limited to 208 acre-feet per annum.

<p>For riparian areas adjacent to the point of diversion, right holder shall establish a setback of at least 30 feet along Maacama Creek for any disturbance during upgrade of the point of diversion or related equipment. The stream setback shall be measured from the top of the bank on the east side of the stream. In areas where existing agriculture allows and/or the riparian vegetation extends beyond 30 feet from the top of bank, the setback shall be extended to the riparian vegetation dripline. Restricted activities within the 30-foot setback area shall include grading, herbicide spraying, paving, new fencing (other than existing), permanent storage, and crop irrigation, with the exception for occasional equipment access necessary for continued operation of the vineyard or used to access or upgrade the point of diversion. Permitted equipment access shall be limited to equipment necessary to support vineyard operation and maintenance activities and reasonable efforts will be made to minimize disturbance of vegetation and soils. Other than activity related to the upgrade of or access to the point of diversion, the setback area shall be protected from disturbance to promote and encourage the recruitment of native riparian shrub and tree species. <p>An erosion control plan and implementation schedule, prepared by a licensed civil engineer, shall be submitted to and approved by the Deputy Director for Water Rights, prior to starting construction. Before storing water in the reservoir, right holder shall furnish evidence which substantiates that the erosion control plan has been implemented. Evidence includes photographs showing the project area vegetation and slopes.</p>	Right holder	Pre-construction, ongoing	Division of Water Rights
<p>No water shall be diverted under this right unless the flow in Maacama Creek is at or above 97 cubic feet per second, as determined at the point of diversion.</p>	Right holder	Ongoing	Division of Water Rights
<p>No water shall be diverted under this water right unless right holder is bypassing the flow required by this water right by use of a passive bypass device.</p> <p>Right holder shall provide the Division of Water Rights with evidence that the device has been installed with the first annual report submitted after device installation. Right holder shall provide the Division of Water Rights with evidence that substantiates that the device is functioning properly every year after device installation as an enclosure to the current annual report or whenever requested by the Division of Water Rights. <p>No water shall be diverted under this right unless right holder is operating in accordance with a compliance plan, satisfactory to the Deputy Director for Water Rights. Said compliance plan shall specify how right holder will comply with the terms and conditions of this right. <p>No water shall be diverted or used under this right, and no construction related to such diversion shall commence, unless right holder has obtained and is in compliance with all necessary permits or other approvals required by other agencies. If an amended right is issued, no new facilities shall be utilized, nor shall the amount of water diverted or used increase beyond the maximum amount diverted or used during the previously authorized development schedule, unless right holder has obtained and is in compliance with all necessary requirements, including but not limited to the permits and approvals listed in this term.</p> <p>Within 90 days of the issuance of this right or any subsequent amendment, right holder shall prepare and submit to the Division of Water Rights a list of, or provide information that shows proof of attempts to solicit information regarding the need for, permits or approvals that may be required for the project. At a minimum, right holder shall provide a list or other information pertaining to whether any of the following permits or approvals are required: (1) lake or streambed alteration agreement with the Department of Fish and Wildlife (Fish & G. Code, § 1600 et seq.); (2) Department of Water Resources, Division of Safety of Dams approval (Wat. Code, § 6002); (3) Regional Water Quality Control Board Waste Discharge Requirements (Wat. Code, § 13260 et seq.); (4) U.S. Army Corps of Engineers Clean Water Act section 404 permit (33 U.S.C. § 1344); and (5) local grading permits.</p> <p>Right holder shall, within 30 days of issuance of any permits, approvals or waivers, transmit copies to the Division of Water Rights.</p>	Right holder	Pre-construction, Ongoing	Division of Water Rights
<p>No water shall be diverted under this right unless right holder is operating the water diversion facility for the point of diversion with a fish screen satisfactory to the Deputy Director for Water Rights. The fish screen shall be designed and maintained in accordance with the screening criteria of the National Marine Fisheries Service. Right holder shall provide evidence that demonstrates that the fish screen is in good condition with the annual report and whenever requested by the Division of Water Rights.</p>	Right holder	Pre-construction, ongoing	Division of Water Rights

<p>Should any buried archeological materials be uncovered during project activities, such activities shall cease within 100 feet of the find. Prehistoric archeological indicators include: obsidian and chert flakes and chipped stone tools; bedrock outcrops and boulders with mortar cups; ground stone implements (grinding slabs, mortars, and pestles) and locally darkened midden soils containing some of the previously listed items plus fragments of bone and fire affected stones. Historic period site indicators generally include: fragments of glass, ceramic, and metal objects; milled and split lumber; and structure and feature remains such as building foundations, privy pits, wells and dumps; and old trails. The Deputy Director for Water Rights shall be notified of the discovery and a professional archeologist shall be retained by the right holder to evaluate the find and recommend appropriate mitigation measures. Proposed mitigation measures shall be submitted to the Deputy Director for Water Rights for approval. Project-related activities shall not resume within 100 feet of the find until all approved mitigation measures have been completed to the satisfaction of the Deputy Director for Water Rights.</p>	Right holder	Ongoing	Division of Water Rights
<p>If human remains are encountered, then the right holder shall comply with the California Environmental Quality Act Guidelines Section 15064.5(e)(1) and the Health and Safety Code Section 7050.5. All project-related ground disturbances within 100 feet of the find shall be halted until the county coroner has been notified. If the coroner determines that the remains are Native American, the coroner will notify the Native American heritage Commission to identify the most-likely descendants of the deceased Native Americans. Project-related ground disturbance in the vicinity of the find shall not resume until the process detailed under CEQA Guidelines Section 15064.5(e) has been completed and evidence of completion has been submitted to the Deputy Director for Water Rights.</p>	Permittee	Ongoing	Division of Water Rights
