Irrigation, Frost Protection, Heat Control, Recreational and Fire Protection

Place of Use:

80 acres total, as follows:

39 acres within SW $\frac{1}{4}$ of projected Section 30, T6N, R3W, MDB&M

2 acres within NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of projected Section 31, T6N, R3W, MDB&M

37 acres within E $\frac{1}{2}$ of SE $\frac{1}{4}$ of projected Section 25, T6N, R4W, MDB&M
