Dear Mr. Ekdahl:

The following is a notification of transfers required by Condition 1.D.ii of the Temporary Urgency Change Order issued on June 1, 2021.

The Department of Water Resources is planning to conduct water transfers under the Lower Yuba River Accord in July, August, and September.

A total of 57 TAF is being released from Yuba's New Bullards Bar Reservoir between July 1 and September 30 for transfer. This volume will be exported through the CVP's Jones Pumping Plant beginning as early as July 16 and will be delivered to the federal contractors. The SWP will export the Yuba water that had been backed into Lake Oroville since November and will either be delivered directly to SWP contractors participating in 2021 purchase of Yuba water, or will be stored in San Luis Reservoir for those parties. The Lower Yuba River Accord is a long-term transfer program, which was granted Board approval on 3/18/2008. As noted in Order 2008-0014 issued by the State Board, "The record shows that the requested transfer is in accord with the State Water Board's responsibilities under the public trust and reasonable use doctrines. The record shows that the requested transfer, as conditioned, will not injure any legal user of water. The record shows that the requested transfer, as conditioned, will not unreasonably harm fish, wildlife, or other instream beneficial uses of water."
