Petitioner and Plaintiff BlueTriton Brands, Inc. ("Petitioner" or "BTB") filed a Motion for Stay, or Alternatively, Preliminary Injunction. Respondents and Defendants the California State Water Resources Control Board ("SWRCB"), Eileen M. Sobeck, in her official capacity as SWRCB's Executive Director, Michael A.M. Lauffer, in his official capacity as Chief Counsel of the SWRCB, the SWRCB Administrative Hearings Office ("AHO"), and the AHO's Presiding Officer (collectively, "Respondents") opposed the motion.
