REPORTING AND COMPLIANCE REQUIREMENTS FOR CEASE AND DESIST ORDER WR 2023-0042, BLUETRITON BRANDS, INC.

On September 19, 2023, the State Water Resources Control Board (State Water Board) adopted Order WR 2023-0042 (Order), issuing a cease-and-desist order against BlueTriton Brands, Inc. (BlueTriton). As part of the Order, BlueTriton is required to submit information to the Division of Water Rights Enforcement Section (Enforcement Section) with information described on pages 95-96 of the Order's pdf file. This letter provides BlueTriton with additional details needed to submit the information in accordance with the Order.

Monthly Reporting

You must implement the compliance actions described in the Order on or before November 1. In addition, you must submit the information required in 1.b of the Order on or before November 15, 2023. Each subsequent monthly report must include all the information the Order requires for the prior calendar month. The monthly reporting should be submitted electronically on the enclosed BlueTriton WR Order Reporting Templates, and emailed to the following three recipients:

Furthermore, on or before November 15, 2023, and in accordance with 1.e of the Order, the Enforcement Section requires information to understand BlueTriton's water accounting and to determine compliance with the Order. BlueTriton must describe the location and water measurement methods at all diversion, delivery and discharge points associated with Tunnels 2, 3, 7, 10, 11, 12 and Boreholes 1, 1A, 7, 7A, 7B, 7C and 8. Include the make/model/serial number/type of measurement device including its accuracy and calibration frequency and the qualifications of the individuals who

originally installed the devices and collect operational data. The Enforcement Section should be notified if any of the diversion, delivery or discharge locations or measurement devices are changed, added, or abandoned.

Please also identify a point of contact at BlueTriton for the Enforcement Section to direct correspondence and communications for implementing the Order.
