Re: Request to Extend the 30-Day Response to the SWRCB's Report of Investigation ("ROI")

Dear Mr. Petruzzelli:

Thank you for your letter of January 9, 2018 advising my client, Nestlé Waters North America Inc. ("NWNA") that you will be posting to the Board's web page in the near future most of the materials that the SWRCB's Staff relied upon in preparing the ROI. Accordingly, NWNA is requesting that its response to the ROI be submitted thirty (30) days after the date of the materials' posting.

We believe that in order to provide a complete and comprehensive response to the SWRCB, it is necessary to review the materials that served as the bases for the ROI's preliminary recommendations and conclusions. In addition, we are in the process of searching documents and data from third party sources to supplement the record on water uses and demand in East Twin Creek and its tributaries early in the 20<sup>th</sup> Century. Although we are doing our best to obtain those materials as rapidly as possible, we are dependent upon those third parties to provide them. Unfortunately, to date we have not received some of the information we have requested.

NWNA believes that there may be materials posted on the SWRCB's web site that will be informative, so we are requesting that our response due date be extended thirty (30) days from the date of their posting. We do not anticipate needing additional extensions but we will certainly promptly advise you if that is not the case. Please advise the undersigned in writing if the SWRCB grants this request.
