WITHDRAWAL OF ADMINISTRATIVE CIVIL LIABILITY COMPLAINT FOR FAILURE TO FULFILL OBLIGATIONS UNDER STATE WATER RESOURCES CONTROL BOARD ORDER WR 2015-0026-DWR

On December 15, 2015, the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), issued an Administrative Civil Liability (ACL) Complaint to KRISTY & WYATT STEVEN DARK for failure to fulfill obligations under State Water Board Order WR 2015-0026-DWR¹.

Landowner records were based on the best available information, as provided by the Sonoma County Clerk-Recorder-Assessor's Office. Since no communication was received prior to December 15, 2015, the Division believed KRISTY & WYATT STEVEN DARK to be the owner of parcel number(s) 004-510-033-000.

In response to the December 15, 2015 ACL Complaint, you informed the Division that the owner did not receive the ACL Complaint. Division staff reviewed the information provided and has determined that the ACL Complaint and Order WR 2015-0026-DWR were mailed to the previous owner, who has now submitted the required information. Based on review of the additional information, the Division withdraws the ACL Complaint.
