WITHDRAWAL OF ADMINISTRATIVE CIVIL LIABILITY COMPLAINT FOR FAILURE TO FULFILL OBLIGATIONS UNDER STATE WATER RESOURCES CONTROL BOARD ORDER WR 2015-0026-DWR

On December 15, 2015, the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), issued an Administrative Civil Liability (ACL) Complaint to MARC M & PISANI ELIZABETH M RIPLEY for failure to fulfill obligations under State Water Board Order WR 2015-0026-DWR¹.

Landowner mailing addresses were based on the best available information, as provided by the Sonoma County Clerk-Recorder-Assessor's Office. Since no communication was received prior to December 15, 2015, the Division believed 7749 FRENCH LN to be the mailing address for 076-142-071-000.

The ACL Complaint was not delivered to MARC M & PISANI ELIZABETH M RIPLEY and was returned to the State Water Board on January 28, 2016. The information required by Order WR 2015-0026-DWR was submitted for parcel numbers 076-142-071-000 on January 8, 2016. Based on this information, the Division withdraws the ACL Complaint.
