### NOTICE OF VIOLATION

On February 21, 2024, staff from the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), in coordination with California Department of Fish and Wildlife (CDFW) conducted a consent inspection of the property referenced above (Property). The purpose of the inspection was to observe the diversion and use of water occurring on the Property and to evaluate potential impacts to the watershed.

You are being contacted because you were identified as one of the property owners of the Humboldt County APN identified above where you are allegedly diverting and using water for domestic use.

During the consent inspection, Division staff observed California Water Code (WC) violations. Enclosed is the Division's Inspection Report (Report) of your Property that includes Division staff observations, alleged violations, and the corrective actions necessary for compliance with the WC and the State Water Board's Policy. The enclosed Report constitutes your 2<sup>nd</sup> notice of the alleged violations, and this matter requires your immediate attention. The field NOV (Photo 33) given to you during the inspection constitutes the 1<sup>st</sup> notice of the alleged violations. The information below is a summary of the alleged violations included in the Report.

The State Water Board retains the authority and discretion to take enforcement action based on the facts and allegations contained herein and you may be subject to further enforcement action before the State Water Board. Therefore, this matter requires your immediate attention. You should follow all staff recommended corrective actions described in the enclosed Report or submit a response indicating any course of action you intend to take or have taken, include an implementation schedule, and/or photo documentation that demonstrates your compliance. You can provide your response, documentation and photos through the Division of Water Rights Cannabis Response Notice Portal detailed in the Report in the **Compliance Assistance References section**.
