NOTICE OF VIOLATION

Dear Zhulieta Shushkova,

On April 29, 2025, staff from the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), in coordination with California Department of Fish and Wildlife (CDFW) conducted a consent inspection of the property referenced above (Property). The purpose of the investigation was to observe the diversion and use of water occurring on the Property and to evaluate potential impacts to the watershed.

During the investigation, Division staff observed violations of the California Code of Regulations (CCR), Water Code (WC) and the State Water Board's Cannabis Cultivation Policy (Policy). Enclosed is the Division's Inspection Report (Report) of your Property that includes Division staff observations, alleged violations and the corrective actions necessary for compliance with the CCR, WC and the Policy. The enclosed Report constitutes your notice of the alleged violations, and this matter requires your immediate attention. The information below is a summary of the alleged violations included in the Report.
