NOTICE OF VIOLATION

DIVISION OF WATER RIGHTS INVESTIGATION OF TRINITY COUNTY ASSESSOR PARCEL NUMBER (APN) 011-210-087-000, 011-210-003-000

On April 29, 2025, staff from the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), in coordination with state and local partner agencies conducted a consent inspection of the property referenced above (Property). The purpose of the investigation was to observe the diversion and use of water occurring on the Property and to evaluate potential impacts to the watershed.

During the investigation, Division staff observed California Water Code (WC) violations that require corrective actions. Enclosed is the Division's Inspection Report (Report) of your Property that includes Division staff observations, alleged violations and the corrective actions necessary for compliance with the WC. The enclosed Report constitutes your notice of the alleged violations, and this matter requires your immediate attention.
