NOTICE OF VIOLATION

On July 9, 2026, staff from the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), in coordination with Department of Cannabis Control (DCC) inspected the property referenced above (Property). The purpose of the inspection was to observe the diversion and use of water occurring on the Property and to evaluate potential impacts to the watershed.

During the investigation, Division staff observed Cannabis Cultivation Policy (Policy) violations. Enclosed is the Division's Inspection Report (Report) of the Property that includes Division staff observations, alleged violations and the corrective actions necessary for compliance with the WC and the State Water Board's Policy. The enclosed Report constitutes your notice of the alleged violations.

The State Water Board retains the authority and discretion to take enforcement action based on the facts and allegations contained herein and you may be subject to further enforcement action before the State Water Board. You should follow all staff recommended corrective actions described in the enclosed Report or submit a response indicating any course of action you intend to take or have taken, include an implementation schedule, and/or photo documentation that demonstrates your compliance. You can submit supporting documentation directly to Division staff as described at the end of this Report in the **Compliance Assistance References section**.
