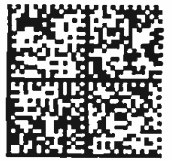

<p>The above assessment is based upon amounts due for the annual fee on a Water Rights Permit or License as required under California Code of Regulations, Title 23, Section 1066.</p> <p>Information concerning Determinations</p> <p>A person upon whom a determination is made or any person directly interested may petition for reconsideration with the State Water Resources Control Board within 30 days from the date of this notice. The State Water Resources Control Board must receive the petition for reconsideration by the 30th day. A petition for reconsideration must be in writing and state the specific grounds upon which it is founded, including an explanation why the petitioner believes that no fee is due or how the petitioner believes that the amount of the fee has been miscalculated.</p> <p>Anyone filing a petition should be prepared to submit documentary evidence to support the specific grounds upon request. All petitions for reconsideration must be mailed to the following address:</p> <p>State Water Resources Control Board, Division of Water Rights, P.O. Box 2000, Sacramento, CA 95812-2000</p> <p>Petitions for Reconsideration are governed by Chapter 4(commencing with section 1120) of Part 1 of Division 2 of the Water Code and Article 12 (commencing with Section 768) of Chapter 2 of Division 3 of Title 23 of the California Code of Regulations. The California Water Code and California Code of Regulations may be found at www.waterboards.ca.gov/laws_regulations/.</p> <p>The filing of the petition will not prevent the accrual of interest. Prompt payment of undisputed portions of the liability should be made. This will prevent accrual of additional interest thereon and will not in any way affect the protested portions. The application of additional penalty would be deferred until 30 days after the date of a Notice of Redetermination.</p>
