I wanted to follow up with you about the Administrative Civil Liability Complaint you received concerning your water right identified as A004383. Unfortunately at this point there are only two options available.

Option 1:

- 1. File the Annual Reports of Licensee for 2016 and 2017 by logging into the State Water Board's website using the Username and Password identified in Username and Password Sheet mailed along with the ACL Complaint, and
