Hearing Officer Maguire has reviewed the Protest Withdrawal Agreement Between Amador Water Agency and the Department of Water Resources and Request for Status Conference filed on September 17, 2020. In light of that agreement, and the recent Protest Withdrawal Agreement between Amador Water Agency, Jackson Valley Irrigation District, and the East Bay Municipal Utility District, Hearing Officer Maguire has decided to postpone the hearing and grant the request for a Status Conference with the hearing parties.

The Amador Water Agency Hearing is hereby postponed. The hearing will not occur on September 29 and 30, 2020. Please continue to hold October 22nd on your calendars, as this date may be used for a rescheduled hearing.
