DECLARATION OF CHUCK DELLA SALA IN SUPPORT OF PROPOSED MODIFICATIONS TO THE DRAFT CEASE AND DESIST ORDER

I, Chuck Della Sala declare as follows:

1. I am the Mayor of the City of Monterey. I have served as Mayor since November of 2006 and served as a City Council Member for four years prior to becoming Mayor. If called as a witness, I would and could testify competently based upon my personal knowledge of the following:

2. In my capacity as the Mayor of the City of Monterey and as a Council Member I am familiar with the City's history, its present issues and concerns, and its needs and goals for the future. Additionally, I grew up in Monterey and maintain a business within the City.

3. Monterey was founded on June 3, 1770. The City incorporated in 1850 – the same year that California joined the United States as approved by delegates meeting at Monterey's Colton Hall. Monterey is approximately eight square miles and, according to the 2000 census, has a population of 29,674 residents. The City has approximately 12,600 households. In terms of area, approximately 28% is designated open space and available to residents and visitors alike for both active and passive use. We average approximately two million visitors each year to our City. Monterey combines a healthy mixture of commercial and residential development located within an urban forest in excess of 25,000 trees. The City is almost entirely built out.

While it is difficult to predict precisely or quantify the exact effect of a moratorium, or water rationing on replacement or remodeling of existing homes and businesses, if adopted as proposed the draft CDO would have significant impacts on the City including: A) limiting the development of affordable housing; B) reducing transient occupancy tax (TOT), property and sales tax revenues; C) eliminating community programs, facilities, and services offered by the City; and consequently D) endangering the public health and safety of the City's citizens and visitors. The draft CDO would most likely result in a moratorium in new water service connections as well as water rationing within the California-American Water Company (Cal-Am) service area which would include the City of Monterey.

4. The opportunities for development in the City of Monterey are essentially limited to replacement and remodeling of existing buildings, aging housing and commercial stock, and City infrastructure. From 1980 to 1993 the Monterey Peninsula Water Management District (MPWMD) established water allocations for the City and other jurisdictions based on Cal-Am production limits. Since 1993 specific water allocations were issued to each jurisdiction when new water sources were developed. State Water Resources Control Board Order 95-10 was issued on July 6, 1995. No water has been allocated to the City since that time. The City exhausted its allocation in early 2003 by either pre-committing or allocating our remaining water resources to projects. However, approximately five (5) acre-feet of pre-commitments and/or allocations have not yet been exercised. Projects including development of 25 affordable housing units, public restrooms, and a redevelopment site in the City's downtown devastated by a fire in early 2007 would be stopped by a moratorium. A moratorium would also prevent other redevelopment sites from proceeding and would likely adversely impact rehabilitation of the City's infrastructure. Most importantly, a moratorium would effectively stifle the fledgling economic growth the City is currently afforded and upset the balance of vitality and general health of the community. A

moratorium would severely constrain the redevelopment of the City by restricting projects to existing water credits available on individual sites.

5. Operating revenues for the City are based primarily on transient occupancy tax (TOT), property taxes and sales taxes. The TOT comprises 27% of the City's revenue, while property tax represent approximately 15%, and sales tax 14%. The City receives a significant economic enhancement when properties are redeveloped and subsequently reassessed at higher values. The City processes hundreds of building permits annually that involve redevelopment. A moratorium or rationing of water could affect the ability of local visitor-serving establishments to effectively utilize and/or remodel aging facilities. This in turn would become a deterrent to visitors who might otherwise choose Monterey as a destination. A loss in visitor-serving related businesses, which account for a significant portion of the City's annual revenues. As referenced above, this would result in reduced services to residents and prevent the City from properly stewarding our natural environmental amenities.

6. To date, the City of Monterey as well as other district jurisdictions have made significant sacrifices and gone to great lengths to conserve water. MPWMD requirements related to conservation are among the most stringent in the state and exceed requirements of most districts in the State of California. Within the MPWMD, residents of jurisdictions must meet, and many have exceeded, MPWMD conservation goals. The City has instilled strong water conservation ethics by installing low-flow water fixtures throughout City buildings, drought-tolerant landscaping, and drip irrigation. The City continually educates residents and the development community on conservative water use through development based wholly on sustainability and green building practices. The City has maintained an active role in regional dialogs such as the Division of Ratepayer Advocates regarding use of recycled and reclaimed water, stormwater runoff, and other technical solutions to recapture and reuse water. Virtually all of the City slopes toward Monterey Bay and these slopes are replete with springs and runoff through streets, which act as a filtering agent for groundwater resources.

specifically, many of our narrow streets are not paved to their full width, leaving an undeveloped permeable right-of-way or linear greenbelt of five (5) to twenty (20) feet on each side of the roadway, which act as a run-off filter. The City of Monterey leads by example by encouraging in-fill redevelopment that employs sustainable building practices including the wise use of water resources.

I declare under a penalty of perjury under the laws of the State of California that the foregoing is true and correct, and that this declaration is executed this 8th day of July, 2008 at Monterey, California.
