SUBJECT: RMA 13-020, General Waste Discharge Requirements for Composting Operations, SWRCB NOP EIR

Pursuant to your request, this office has reviewed the subject Notice of Preparation (NOP) of Environmental Impact Report (EIR) package.

PROJECT DESCRIPTION

To protect ground and surface water quality, the State Water Board proposes to adopt general waste discharge requirements that would provide coverage for composting operations in the State of California for use by the Regional Water Quality Control Boards (Regional Water Board). It would be at the discretion of each Regional Water Board whether to apply the General Waste Discharge Requirements for Composting Operations (Order) to facilities in their region. The Order would apply to all areas used for the receipt, processing, and storage for the conversion of certain eligible organic materials into a compost product. The Order will include conditions that would address appropriate water quality protection measures at existing and proposed composting operations that seek coverage under the Order. The construction of new composting operations and the expansion of existing composting operations would be regulated by local land use authorities; this Order would not permit the actual construction of any new facilities or the expansion of existing facilities.

WATERSHED PROTECTION DISTRICT PROJECT COMMENTS:

It is noted that the draft requirements specify control measures for runoff from a 25-year peak storm event. The Ventura County Watershed Protection District typically considers impacts from a 100-year (1-percent chance) event for design and protection purposes. It is suggested that language be incorporated into the composting requirements to explain the State Water Board's position on control measures for the 100-year (1-percent chance) runoff event. It could be helpful to have a statement indicating whether this is beyond the intended scope of the regulations, or that consideration of such additional requirements is deferred to local land use authorities.
