RULING ON ORDER OF PRESENTATION: HEARING ON DRAFT CEASE AND DESIST ORDER REGARDING DELTA SALINITY AND WATER QUALITY RESPONSE PLAN

This ruling responds to your request for an order of presentation for the hearing commencing October 24, 2005. This is the hearing on the draft cease and desist orders against the Department of Water Resources (DWR) and the U.S. Bureau of Reclamation (USBR) and on the petitions for reconsideration of the approval of the Water Quality Response Plan (Plan). Approval of the Plan is a condition of the DWR and the USBR using each other's points of diversion in the southern Delta.
