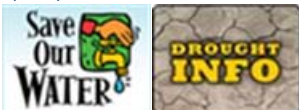

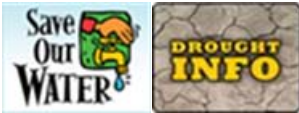

**TO PARTIES:**

Ladies and Gentlemen:

The Hearing Team has received the final Reporter's Transcript (MONDAY, JANUARY 25, 2016). The transcript is posted at the [project webpage](#). Accordingly, pursuant to our January 25, 2016, [BRIEFING SCHEDULE](#) distributed to Parties at the conclusion of the hearing, supplemental briefs on evidentiary objections are due by **Monday, April 11, 2016, at 5:00PM**. As a reminder, parties are limited to a single supplemental brief, not to exceed 20 pages, which may address any or all of the outstanding evidentiary objections as parties see fit.

The Hearing Officers may grant an extension of the briefing deadlines on a showing of good cause. Any party may request an extension of the briefing deadlines. Such requests should be filed not later than Friday, April 1, 2016. Reply briefs, not to exceed 10 pages, will be due one week after the deadline for submission of supplemental briefs.

Regarding Prosecution Team Exhibit WR-153, parties should identify whether there is any controversy as to the scope of Mr. Fahey's objections. The Hearing Team will leave it to the parties to address the proper scope in their briefs (with citations to the transcript and exhibit, of course), addressing Mr. Fahey's objection that the PT failed to disclose rebuttal exhibit WR-153 prior to the hearing.
