2.1 Written and Oral Comments and Responses

The organizations, groups, and individuals listed below have provided written and oral statements on the Imperial Irrigation District Water Conservation and Transfer Project Draft Habitat Conservation Plan and Draft EIR/EIS. Imperial Irrigation District and Reclamation received 232 comment letters as well as oral testimony from 31 individuals. Written statements were accepted through the Imperial Irrigation District and the Reclamation from January 18 through April 26, 2002. Oral comments were received at three public hearings held on April 2, 3, and 4 in La Quinta, El Centro, and San Diego, respectively. A court reporter was present to take a verbatim transcript of each proceeding.

Each commenter was assigned a group code, which is illustrated in Table 2-1. This table can be used as a reference when reading Section 5, Responses to Comments on the Draft EIR/EIS. Following is a list of commenter types who submitted written and oral comment statements during the Draft EIR/EIS review period.
