Dear Mr. Baiocchi:

The prehearing conference for Yuba County Water Agency's change and long-term transfer petitions was held at 10 am October 25, 2007. Although Anglers Committee of California (Anglers Committee) filed a Notice of Intent to appear at the hearing, to present direct testimony and participate in cross-examination or rebuttal, no Anglers Committee representative attended the pre-hearing conference. Additionally, Anglers Committee sent a letter to State Water Board staff on October 22, 2007, stating that Anglers Committee did not intend to participate in either the pre-hearing conference or the hearing itself.

**By November 1, 2007, please inform us if there is any change from your previously stated intent not to participate in the hearing.** If so, please inform us of the reason for your failure to attend the pre-hearing conference, and confirm that you plan to attend the hearing. Otherwise, any participation you have in the hearing will be limited to making a policy statement.

If you do not intend to participate in the hearing, as your letter indicated, your submittals thus far in the process will be considered by the board as a policy statement.
