### ORDER WR 2006-0009 - CHANGING THE EFFECTIVE DATE OF LONG-TERM INSTREAM FLOW REQUIREMENTS

As described in California Code of Regulations, title 23, section 768, any interested person may file a petition for reconsideration upon any of the following causes:

- (a) Irregularity in the proceedings, or any ruling, or abuse of discretion, by which the person was prevented from having a fair hearing;
- (b) The decision or order is not supported by substantial evidence;
- (c) There is relevant evidence which, in the exercise of reasonable diligence, could not have been produced;
- (d) Error in law.
