POSTPONEMENT OF HEARING TO DETERMINE WHETHER TO REVOKE LICENSE 659  
(APPLICATION 553) OF MORONGO BAND OF MISSION INDIANS, MILLARD  
CANYON, RIVERSIDE COUNTY

On April 16, 2004, the Morongo Band of Mission Indians (Morongo Band) filed a petition for reconsideration of my ruling denying the Morongo Band's petition to disqualify the State Water Resources Control Board (SWRCB) enforcement team from participation in the above water right hearing scheduled for Tuesday, June 15, 2004. The hearing is postponed pending action on the petition for reconsideration. Since the hearing will be postponed, the May 18, 2004 deadline for filing a Notice of Intent to Appear (NOI) and June 1, 2004 deadline for submittal of exhibits and testimony no longer apply. A revised Hearing Notice will be issued in the future and will include a new hearing date, as well as new deadlines for submitting NOIs, exhibits, and testimony. All those on the enclosed mailing list will be notified when the hearing is rescheduled.

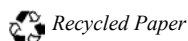
