ORDER DETERMINING THE LEGAL CLASSIFICATION OF GROUNDWATER

The enclosed revised draft order regarding the legal classification of groundwater pumped by the North Gualala Water Company is being scheduled for discussion at the State Water Resources Control Board's (SWRCB) February 19, 2003 Board meeting, to be held in Sacramento in the California Environmental Protection Agency building, 1001 I Street. You will receive a notice of the meeting with the exact date, time and location ten days prior to the meeting. This information will also be posted on the Division of Water Rights website at http://www.waterrights.ca.gov. Click on "Hearings Program," then "Current Hearing Projects," then "North Gualala Water Company Hearing".

Each person will have a brief opportunity to comment on the proposed order. All presentations should be limited to 5 minutes. Comments should be limited to the general acceptability of the order or possible technical corrections. Parties may not introduce evidence at the SWRCB meeting. Parties should submit in writing any comments or changes to the proposed order they would like the SWRCB to consider at the meeting. All written comments should be received by the SWRCB no later than 12:00 noon Friday, February 14, 2003. Written submittals may be addressed to:
