SANTA CLARITA WATER COMPANY (APPLICATION 29898)

I have received your letter dated May 16, 2003 regarding the withdrawal of Santa Clarita Water Company's (Santa Clarita) Application 29898. The State Water Resources Control Board (SWRCB) received a letter dated May 15, 2003 from Mr. Arthur Kidman of McCormick, Kidman & Behrens, LLP, which now represents Santa Clarita. Included in the letter was a copy of a resolution from the Board of Directors of the Santa Clarita Water Company requesting withdrawal of Application 29898 to appropriate water from the Santa Clara River.
