Susan: I went through my notes from the meeting yesterday and came up with the following:

- 1. SWRCB will review Final EIS/EIR before publication by Reclamation. 30 to 45 days after document final, Reclamation will sign a Record of Decision (ROD); DWR will do a Notice of Determination. DWR will certify project and approval of TROA.
- 2. Sue Oldham, Attorney for Truckee Meadows Water Authority, stated that TROA needs to be completed by 2009. Working on \$1 million appropriation for each signatory including State of California (DWR and SWRCB).
- 3. Reclamation will submit the Petition for Extension of Time for Stampede Reservoir, Permit 11605. Susan Wilson will add Stampede Petition for Extension of Time to the notice. The notice will then be sent to Legal and the Board for review, which may take 4 weeks. After review and edits, and prior to the notice being mailed to interested parties, the notice will be sent to Marty Kaiser, Reclamation, for review by TROA parties.
- 4. TROA petitions/applications will be noticed for 60 days. If EIS/EIR on the street, parties involved feel people will better understand TROA and may not protest. SWRCB cannot issue a final decision until EIS/EIR is final. Applicants will have 180 days (?) to respond to protests. Applicants may request a hearing if they feel protests cannot be resolved.
- 5. The short notice form will be used by SWRCB for the mailing and will direct the reader to the Board's website where the full notice will be available. Per Vicky Whitney, Reclamation may use the short notice for publication requirements. Notice must be published in newspapers where points of diversions are located. Notice must be published once-a-week for three weeks. Counties in Nevada: Storey, Washoe, Churchill and Lyon Counties. Marty Kaiser will check counties in California where points of diversion are located. Check Susan Wilson's list of newspapers and their addresses.
- 6. Kenneth Parr, Reclamation, will reconsider putting the Petition for Extension of Time for Stampede Permit 11605 in the EIS/EIR. Advise Susan Wilson, SWRCB, as soon as a decision is made as to whether or not the Stampede Extension Petition will be included in the EIS/EIR.
- 7. Printing and mailing of notice compare mailing lists of Susan Wilson and Reclamation. The notice and EIS/EIR should be sent to the same group of people. Susan Wilson will share her mailing list with Reclamation via email.
- 8. Send draft of Stampede Extension Petition to Susan Wilson.

I hope I got everything down in my notes. If you think of something I've missed, please let me know. Thanks for all your help on this project.
