SUBJECT OF THE HEARING

The purpose of this hearing is to receive evidence that will assist the State Water Resources Control Board (SWRCB) in determining whether and under what conditions to approve a Petition for Long-Term Transfer filed on March 19, 2001 by the Merced Irrigation District (Merced) and Modesto and Turlock Irrigation Districts (MID/TID) (collectively referred to herein as "petitioners") pursuant to Water Code sections 1707 and 1735 et seq. The petitioners seek approval of a long-term transfer of water and change in place of use and purpose of use of water under Merced's Licenses 2685, 6047, and 11395 (Applications 1224, 10572, and 16186) and MID/TID's Licenses 5417 and 11058 (Applications 1233 and 14127). The petitioners propose to transfer up to 47,000 acre-feet of water. The purpose of the proposed transfer is to conduct the Vernalis Adaptive Management Plan (VAMP) experiments. In Decision 1641 as revised by Order WR 2000-02¹ (D-1641), the SWRCB approved a similar petition; the water under this petition is in addition to the water transferred under D-1641.

Copies of witnesses' proposed testimony, exhibits, list of exhibits, and qualifications must be served upon and received by the SWRCB and each of the parties who have indicated their intent to appear no later than **4:00 p.m. on Monday, March 3, 2003**.

By **December 9, 2002**, hearing participants were required to serve a copy of their Notice of Intent to Appear on each of the parties identified on the list of parties to exchange information and on the SWRCB, along with a statement of service that indicates the manner of service.
