

PROPOSED ORDER DENYING PETITION TO CHANGE POINT OF DISCHARGE. PLACE OF USE, AND PURPOSE OF USE OF TREATED WASTEWATER

The State Water Resources Control Board (SWRCB) will consider the enclosed draft order regarding Victor Valley Wastewater Reclamation Authority's (VVWRA) petition for change of point of discharge, place of use and purpose of use of treated wastewater, at a workshop scheduled for Thursday, October 18, 2001, starting at 10:00a.m. in the Coastal Hearing Room on the second floor of the Cal/EPA Headquarters Building at 1001 I Street in Sacramento. The SWRCB will consider whether to adopt the proposed order at a future SWRCB meeting, which will be noticed separately.

At the Board workshop, the parties will have a brief opportunity to comment on the proposed order. Each party identified on the Service List of Participants should limit their presentation to 10 minutes and interested persons should limit their presentations to 5 minutes. Comments should be limited to the general acceptability of the proposed order, or to possible technical corrections. Parties may not introduce evidence at the SWRCB workshop.
