HEARING DATES

As noted above the hearing has been rescheduled to commence on:

1) Monday, January 11, 2016 and continue, as necessary, on January 12 through 15, 2016 for cases-in-chief, and reconvene; 2) Thursday, February 4, 2016 and continue, as necessary, on February 5, 2016 for oral summation of written rebuttal testimony and cross-examination of rebuttal testimony.¹ Please note that the start times may be earlier than 9 a.m. on subsequent hearing days if the hearing officer determines it necessary. Any change in start times will be announced at the conclusion of the previous hearing day. Please also note that on January 11 through January 14, 2016 the hearing will be held in the Sierra Hearing Room and on January 15, February 4, and February 5, 2016, the hearing will be held in the Coastal Hearing Room. The Sierra and Coastal Hearing rooms are adjacent rooms in the Joe Serna Jr.-CalEPA Building.

Until such time as the hearing officer rules on the motion, the hearing shall remain scheduled as set by the hearing officer's ruling of November 6, 2015.
