an Unnamed Stream tributary to Arroyo Sausal thence Walker Creek thence Tomales Bay in Marin County

#### Point of Diversion:

South 1500 feet and West 1800 feet from Northeast corner of projected Section 36, Township 4 North, Range 8 West, Mount Diablo Base and Meridian, being within the Southwest quarter of Northeast quarter of projected Section 36.

Annual Storage Amount:
23 acre-feet per year of collection to storage
19 acre-feet per year of withdrawal from storage

Season of Diversion:

December 1 of each year to April 30 of the succeeding year.

Purpose of Use: Stockwatering

Place of Use:

Within Northwest quarter of Northeast quarter and at Reservoir within Southwest quarter of Northeast quarter of projected Section 36, Township 4 North, Range 8 West, Mount Diablo Base and Meridian.
