Notice of Minor Change to Water Right Application A031284

The State Water Resources Control Board (State Water Board) has initiated a minor change under Water Code section 1700.4 to make changes to pending water right application A031284. The project associated with the application and minor change is in Madera County and would divert water from the Fresno River stream system.

Summary of Water Right Application A031284

Date of Filing: The application was filed with the State Water Board on January 23, 2002.

Source of Water: The sources of water are three unnamed streams, which are tributary to Coarse Gold Creek thence the Fresno River.

Amount: The maximum amount of water requested for diversion is 44.25 acre-feet per year.

Season of Diversion: The season for diversion of water is from January 1 to December 31 of each year.

Point of Diversion: Water will be diverted from three points:

- The first point is located at North 1,885,703 feet and East 6,789,614 feet by California Coordinate System, Zone 3, North American Datum 1983, within the Southeast quarter of the Southeast quarter of Section 6, Township 9 South, Range 21 East, Mount Diablo Base and Meridian.
- The second point is located at North 1,888,061 feet and East 6,792,875 feet by California Coordinate System, Zone 3, North American Datum 1983, within the Southeast quarter of the Northwest quarter of Section 5, Township 9 South, Range 21 East, Mount Diablo Base and Meridian.
- The third point is located at North 1,889,781 feet and East 6,794,875 feet by California Coordinate System, Zone 3, North American Datum 1983, within the Northwest quarter of the Northeast quarter of Section 5, Township 9 South, Range 21 East, Mount Diablo Base and Meridian.

Purpose of Use: The purposes of use for water are irrigation, stockwatering, and fish and wildlife preservation and enhancement.

Place of Use: The place of use for stockwatering and fish and wildlife preservation and enhancement is at the three reservoirs. The place of use for irrigation is 71.28 acres within sections 5, 6, and 7, Township 9 South, Range 21 East, Mount Diablo Base and Meridian.

Summary of Minor Change

Source of Water: The source of water has not changed.

Season of Diversion: The season for diversion of water has not changed.

Amount: The maximum amount of water requested for diversion has been changed to 26.95 acre-feet per year.

Point of Diversion: The points where water will be diverted have been changed by removing the first and second points of diversion.

Purpose of Use: The purposes of use for water have been changed by removing irrigation.

Place of Use: The place of use for water has been changed by removing the place of use for irrigation and removing two reservoirs for stockwatering and fish and wildlife preservation and enhancement.
