## State Water Resources Control Board

### Notice of Minor Change to Water Right Application A027988

A minor change has been initiated under Water Code section 1700.4 to make minor changes to water right application A027988 of United States Forest Service, Lake Tahoe Basin Management Unit. The project associated with the application and minor changes is in Placer County and would divert water from the Lake Tahoe stream system.

#### Summary of Water Right Application A027988

**Date of Filing:** The application was filed with the State Water Board on March 6, 1984.

**Source of Water:** The source of water is an Unnamed Stream (aka Quail Lake Creek), which is tributary to Lake Tahoe.

**Season of Diversion:** The season for diversion of water is from November 1 of each year through August 31 of the succeeding year.

**Amount:** The maximum amount of water requested for diversion is 88 acre-feet per year.

**Point of Diversion:** The point where water will be diverted is located at North 2,157,137 feet and East 7,082,663 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Southeast quarter of the Southwest quarter of Section 12, Township 14 North, Range 16 East, Mount Diablo Base and Meridian.

**Purpose of Use:** The purpose of use for water is fish and wildlife preservation and enhancement.

**Places of Use:** The places of use for water are Quail Lake Reservoir and a portion of the Unnamed Stream (aka Quail Lake Creek) downstream of Quail Lake Reservoir as follows: (1) the upstream limit is Quail Lake Reservoir dam located at North 2,157,137 and East 7,082,663 by California Coordinate System, Zone 2, North American Datum 1983, within the Southeast quarter of the Southwest quarter of Section 12, Township 14 North, Range 16 East, Mount Diablo Base and Meridian; and (2) the downstream limit is a point on the Unnamed Stream (aka Quail Lake Creek) immediately upstream of the confluence of the Unnamed Stream (aka Quail Lake Creek) and Lake Tahoe, located at North 2,159,240 feet and East 7,086,181 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Northwest quarter of the Northwest quarter of Section 7, Township 14 North, Range 16 East, Mount Diablo Base and Meridian.

## Summary of Minor Change

**Source of Water:** The source of water has not changed.

**Season of Diversion:** The season for diversion of water has not changed.

**Amount:** The maximum amount of water requested for diversion has not changed.

**Point of Diversion:** The point where water will be diverted has not changed.

**Purpose of Use:** The purpose of use for water has not changed.

**Places of Use:** The places of use for water have been changed by removing the Unnamed Stream (aka Quail Lake Creek) as a place of use.
