NOTICE OF PETITION FOR CHANGE FOR WATER RIGHT LICENSE 12598 (APPLICATION 25247) OF CAL-CEL MARKETING INC

On January 24, 2025, Cal-Cel Marketing, Inc. (Petitioner) filed a petition for change for water right License 12598 (Application 25247) with the State Water Resources Control Board (State Water Board), Division of Water Rights (Division). With the change petition, the Petitioner seeks to modify the place of use under License 12598 to the original place of use historically established under the license. Following is a summary of the license and the change requested with the petition.
