Notice of Minor Change to Water Right Application A030290

Brian R. White and Helen White have filed a request for a minor change under Water Code section 1700.4, seeking to make changes to pending water right application A030290. The project associated with the application and minor change is in Mendocino County and would divert water from the Russian River stream system. The purpose of the request, in part, is to align the project description with the conditions agreed upon during the field investigation completed on March 26, 2001. With inclusion of the project modifications described in the Summary of Minor Change section below, and application of the most up-to-date list of standard and mandatory terms, the previously agreed upon conditions may be either duplicative or inapplicable and may not be included in any permit issued on the subject application.

Summary of Water Right Application A030290

Date of Filing: The application was filed with the State Water Board on October 12, 1993.

Source of Water: The sources of water are an Unnamed Stream tributary to McNab Creek thence Russian River thence the Pacific Ocean, and the Russian River tributary to the Pacific Ocean.

Diversion Methods and Amount: Water will be diverted via onstream dam and diversion to offstream storage. The rate of diversion to offstream storage will not exceed 1.2 cubic feet per second. The total amount of water diverted will be limited to 17 acrefeet per year.

Season of Diversion: The season for diversion of water is from November 1 to April 30 of the succeeding year.

Points of Diversion: Water will be diverted at points 1 and 2 and stored and rediverted at Point 1:

 Point 1 (Onstream Dam) is a point of diversion, point of rediversion, and place of storage located at North 2,144,295 feet and East 6,236,724 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Southeast quarter of the Northeast quarter of Section 26, Township 14 South, Range 12 East, Mount Diablo Base and Meridian. Point 2 (Offset Well) is a point of diversion located at North 2,144,191 feet and East 6,239,561 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Southeast quarter of the Northwest quarter of Section 25, Township 14 South, Range 12 East, Mount Diablo Base and Meridian.

Purpose of Use: The purposes of use for water are Irrigation, Frost Protection, Stockwatering, Domestic, and Heat Control.

Place of Use: The place of use is as follows:

- 70 acres within projected Sections 25 and 26 for Irrigation, Frost Protection, and Heat Control;
- Three residences located within projected section 25 for Domestic;
- The reservoir located in projected section 26 for Stockwatering;
- All within Township 14 North, Range 12 West, Mount Diablo Base and Meridian.

Summary of Minor Change

Source of Water: The sources of water have changed to remove the Unnamed Stream tributary to McNab Creek thence the Russian River thence the Pacific Ocean.

Season of Diversion: The season for diversion of water has changed from November 1 through April 30 of the succeeding year to December 15 through March 31 of the succeeding year.

Diversion Methods and Amount: The maximum amount of water requested for diversion has not changed. Diversion methods have changed by removing diversion via onstream dam.

Points of Diversion: The points where water will be diverted have been changed by removing diversion from the unnamed stream at Point 1 (Onstream Dam). Point 1 (Onstream Dam) will still be a point of rediversion and a place of storage for water diverted at Point 2 (Offset Well). The location of Point 2 (Offset Well) has been updated for mapping accuracy by revising the quarter-quarter section to the Northeast quarter of the Southwest quarter of projected section 25, Township 14 South, Range 12 East, Mount Diablo Base and Meridian.

Purposes of Use: The purposes of use for water have not changed.

Places of Use: The places of use for water have not changed.
