NOTICE OF MINOR CHANGE REQUEST FOR PERMITS 21235 and 21404 (APPLICATIONS 30503 and 31799)

County: Riverside

Sources: UNNAMED SUBTERRANEAN STREAM

Eastern Municipal Water District has requested minor changes under Water Code section 1700.6 to update Permits 21235 and 21404. Below is a summary of each water right and the requested change:

Summary for Permit 21235 (Application 30503):

Source: Unnamed Subterranean Stream tributary to West San Jacinto Groundwater Basin within the County of Riverside

Points of Diversion (POD): Water will be diverted from 4 points:

- POD 1: North 2,250,240 feet and East 6,275,770 feet by California Coordinate System NAD 83, Zone 6, within the Southeast quarter of the Northeast quarter of Section 9, Township 4 South, Range 3 West, San Bernardino Base and Meridian.
- POD 2: North 2,250,090 feet and East 6,275,770 feet by California Coordinate System NAD 83, Zone 6, within the Southeast quarter of the Northeast quarter of Section 9, Township 4 South, Range 3 West, San Bernardino Base and Meridian.
- POD 3: North 2,250,110 feet and East 6,276,950 feet by California Coordinate System NAD 83, Zone 6, within the Southwest quarter of the Northwest quarter of Section 10, Township 4 South, Range 3 West, San Bernardino Base and Meridian.
- POD 4: North 2,249,620 feet and East 6,276,620 feet by California Coordinate System NAD 83, Zone 6, within the Northwest quarter of the Southwest quarter of Section 10, Township 4 South, Range 3 West, San Bernardino Base and Meridian.

Purpose of Use: Irrigation, Domestic and Fire Protection

Diversion Rate and Amount: The water use shall not exceed a combined total of 2.75 cubic feet per second by direct diversion from all four points of diversion. The maximum amount diverted shall not exceed 913 acre-feet per year.

Season: January 1 to December 31 each year

Place of Use: Within the McCanna Ranch Water Company Service Area

Summary for Permit 21404 (Application 31799):

Source: Unnamed Subterranean Stream tributary to West San Jacinto Groundwater Basin within the County of Riverside

Points of Diversion (POD): Water will be diverted from 4 points:

- POD 1: North 2,250,240 feet and East 6,275,770 feet by California Coordinate System of 1983, Zone 6, within the Southeast quarter of the Northeast quarter of Section 9, Township 4 South, Range 3 West, San Bernardino Base and Meridian.
- POD 2: North 2,250,090 feet and East 6,275,770 feet by California Coordinate System of 1983, Zone 6, within the Southeast quarter of the Northeast quarter of Section 9, Township 4 South, Range 3 West, San Bernardino Base and Meridian.
- POD 3: North 2,250,110 feet and East 6,276,950 feet by California Coordinate System of 1983, Zone 6, within the Southwest quarter of the Northwest quarter of Section 10, Township 4 South, Range 3 West, San Bernardino Base and Meridian.
- POD 4: North 2,249,620 feet and East 6,276,620 feet by California Coordinate System of 1983, Zone 6, within the Northwest quarter of the Southwest quarter of Section 10, Township 4 South, Range 3 West, San Bernardino Base and Meridian.

Purpose of Use: Municipal

Diversion Rate and Amount: The maximum amount diverted shall not exceed 462 acre-feet per year with a maximum rate of 5.51 cubic feet per second.

Season: January 1 to December 31 of each year

Place of Use: Within the City of Perris Downtown Water System service area

Requested Minor Change for Permits 21235 and 21404:

The Minor Change wishes to add a new POD 5, on Permits 21235 and 21404. Both permits will share the same POD currently authorized under Permit 21403 (Application 31791). The proposed POD 5, is located within the California Coordinate System, NAD 83, Zone 6, North 2,247,983 feet and East 6,272,999 feet being within the Southeast quarter of the Southwest quarter of Section 9, Township 4 South, Range 3 West, San Bernardino Base and Meridian.

No new or adapted facilities are needed to facilitate these changes.

Pursuant to Water Code section 1700.6, any interested person may submit comments regarding the proposed minor changes.
