## <u>Summary of Requested Changes to License 3577 (Application 12975) and Permit 20631 (Application 29494)</u>

## Place of Use:

The requests seek to add 18 acres of existing developed vineyard to the authorized places of use for Applications 12975 and 29494. Kerwin Estates, LLC acquired the property in 2023 and seeks to conform the places of use to the actual irrigated area. The oldest available Google Earth imagery shows vineyard present in 1993 in the area proposed to be added to the place of use. The places of use will be amended as follows:

1 acre within the NW¼ of NW¼ of projected Section 32, T9N, R6W, MDB&M 8 acres within the NE¼ of NW¼ of projected Section 32, T9N, R6W, MDB&M 14 acres within the SW¼ of NW¼ of projected Section 32, T9N, R6W, MDB&M 23 acres within the SE¼ of NW¼ of projected Section 32, T9N, R6W, MDB&M 11 acres within the SW¼ of NE¼ of projected Section 32, T9N, R6W, MDB&M 13 acres within the NW¼ of SW¼ of projected Section 32, T9N, R6W, MDB&M 3 acres within the NE¼ of SW¼ of projected Section 32, T9N, R6W, MDB&M 73 acres total
