**PROJECT DESCRIPTION:** Southern California Edison (SCE) owns and operates the six hydroelectric projects listed above and is seeking new Federal Energy Regulatory Commission (FERC) licenses for these projects, which are all located in the upper San Joaquin River watershed. The individual projects together comprise the Big Creek Hydroelectric System which is managed from both a watershed-wide perspective and on an individual project-by-project basis. It is the intention of the State Water Board to issue a single Section 401 Water Quality Certification that will cover all six of the Big Creek licensed projects.

SCE's proposed project reflects the Settlement Agreement that was negotiated with agencies and interested stakeholders during the Big Creek Alternative Licensing Process (ALP) and finalized in February 2007. Four of the six Big Creek projects were included in the ALP, while the remaining two projects (Portal, FERC Project No. 2174 and Vermilion Valley, FERC Project No. 2086) have undergone the Traditional Licensing Process. The Settlement Agreement includes a set of specific conditions that the settling parties request be incorporated into the new project licenses that includes environmental protection and enhancement measures for all six of the Big Creek projects. The State Water Board is lead agency for the purpose of the California Environmental Quality Act.
