NOTICE OF PETITION FOR RECONSIDERATION OF WATER QUALITY CERTIFICATION FOR PACIFIC GAS AND ELECTRIC COMPANY'S DESABLA-CENTERVILLE HYDROELECTRIC PROJECT, FEDERAL ENERGY REGULATORY COMMISSION PROJECT NO. 803

NOTICE IS HEREBY GIVEN THAT Pacific Gas and Electric Company (PG&E) has petitioned the State Water Resources Control Board (State Water Board) to reconsider the water quality certification issued, pursuant to section 401 of the Clean Water Act (33 U.S.C. § 1341), for the DeSabra-Centerville Hydroelectric Project (Project), Federal Energy Regulatory Commission (FERC) Project No. 803. This Petition for Reconsideration (Petition) was filed pursuant to California Code of Regulations, title 23, section 3867.

BACKGROUND

On April 8, 2015, the State Water Board's Executive Director issued a water quality certification (certification) for the Project, which is undergoing relicensing before FERC. Within 30 days of certification issuance, PG&E filed a Petition of the certification for the Project dated May 8, 2015. Details on the reconsideration request can be found in the Petition, which is available on the State Water Board's Project website as described below.
