Dear Mr. Howard:

In February 2004, PacifiCorp applied to the Federal Energy Regulatory Commission (FERC) for a new major license for its Klamath Hydroelectric Project (Project) on the Klamath River in California and Oregon. In conjunction with that application, on March 29, 2006, PacifiCorp requested that the State Water Resources Control Board (SWRCB) certify the California portions of the Project under section 401 of the federal Clean Water Act (33 USC § 1341, California Water Code § 13160, and 23 C.C.R. Chpt. 28).

Under section 401, if a state does not act on a request for certification within a reasonable time, not to exceed one year, the certification requirement is waived. To allow the SWRCB time to consider PacifiCorp's certification request for the Project, PacifiCorp withdrew and simultaneously resubmitted its request on February 28, 2007, and again on February 22, 2008. On July 11, 2008, PacifiCorp withdrew its request to facilitate negotiations for a long-term settlement of the Project relicensing proceeding. By letters dated August 22, 2008, and September 22, 2008, the SWRCB asked PacifiCorp to resubmit its application for water quality certification so that the certification process could continue. PacifiCorp resubmitted the application to the SWRCB on September 26, 2008.

PacifiCorp again withdrew and simultaneously resubmitted the application on September 10, 2009, August 25, 2010, August 3, 2011, July 17, 2012, December 18, 2012, December 2, 2013, November 24, 2014, and November 10, 2015.

On February 18, 2010, PacifiCorp entered into the Klamath Hydroelectric Settlement Agreement (KHSA) with the states of California and Oregon, the United States, Tribes, and various other stakeholders. The KHSA established a process for removing the four main stem hydroelectric dams on the Klamath River (J.C. Boyle, Copco No. 1, Copco No. 2, and Iron Gate). On April 6, 2016, PacifiCorp, the states of California and Oregon, the United States and other stakeholders amended the KHSA. The amended KHSA provides for transfer of the Project to the Klamath

River Renewal Corporation (KRRC) and subsequent license surrender by the KRRC, subject to FERC approval.

Consistent with the amended KHSA's terms, PacifiCorp filed a motion on May 6, 2016 asking FERC to hold the relicensing proceeding in abeyance pending FERC's determination on the license transfer and surrender applications. On May 23, 2016, the SWRCB submitted a timely answer supporting the motion on the grounds that the SWRCB would continue to expend resources processing PacifiCorp's water quality certification application in the absence of a FERC abeyance. On June 16, 2016, FERC issued an order (155 FERC ¶ 61,271) granting PacifiCorp's motion and holding the relicensing proceeding in abeyance.

With the relicensing proceeding in abeyance, and consistent with Section 6.5.2 of the amended KHSA, PacifiCorp hereby formally withdraws its request for water quality certification dated November 10, 2015. PacifiCorp's withdrawal of its application is consistent with FERC regulations, FERC's abeyance order (155 FERC ¶ 61,271), and without prejudice to PacifiCorp's right to file a new application for water quality certification should circumstances change in the future. In particular, should FERC reactivate the relicensing proceeding, PacifiCorp will timely submit a new request for water quality certification of the Project.

Pursuant to applicable statutes and regulations, PacifiCorp is providing notice of the withdrawal of its application to the Executive Officer of the North Coast Regional Water Quality Control Board, via copy of this letter.

Dear Mr. Stine:

In February 2004, PacifiCorp applied to the Federal Energy Regulatory Commission (FERC) for a new major license for PacifiCorp's Klamath Hydroelectric Project. In conjunction with that application, on March 29, 2006, PacifiCorp requested that the Department of Environmental Quality (DEQ) certify the Oregon portions of the project pursuant to section 401 of the federal Clean Water Act (CWA).

Under section 401, if a State does not act on a request for certification within a reasonable time, not to exceed one year, the certification requirement is waived. In order to allow DEQ additional time to consider the certification request for the Project, PacifiCorp withdrew and simultaneously resubmitted the request in letters dated February 28, 2007, February 21, 2008, February 6, 2009, January 20, 2010, January 10, 2011, January 3, 2012, December 18, 2012, December 2, 2013, November 24, 2014, and November 10, 2015.

On February 18, 2010, PacifiCorp entered into the Klamath Hydroelectric Settlement Agreement (KHSA) with the states of Oregon and California, the United States, Tribes, and various other stakeholders.
